### Special Features of the Centralised Admission Portal

- Any student across the country who has passed (10+2) examination can apply for admission to the Undergraduate Courses/Programmes, as per preferences, in all the Colleges/HEIs which are under the purview of Centralised Admission Portal. The applicant does not have to search for individual websites of Colleges/HEIs separately.
- No application fee will be charged.
- An applicant can apply for a maximum of 25 Courses/Programmes.
- To properly guide the candidates, SMS will be sent to them in each stage of admission process, as applicable.
- Based on higher preference and on the availability of seats, an applicant will be allotted a single seat only.
- The Merit List for all Courses of all Colleges/HEIs will be generated on the same day at the same time.
- An applicant will have the scope of upgrading his/her preference even after taking admission.
- All kinds of Fee related to Admission can be paid only through the Portal.
- An applicant will have to pay the Admission Fee initially. In case of upgradation, only the additional fee, if any, will have to be paid. However, the candidate needs to cancel the previous admission for upgradation. If the Admission Fee in the new Course/Programme is lesser, his/her balance fee will be refunded after the completion of the entire admission process.

The competent authority in the State Government introduced the system of Centralised Online Admission to the undergraduate courses in colleges and universities in order to provide a single-window gateway to facilitate the admission process in the academic session 2026-27. Now, the Centralised Admission Portal shall go live for admission to the undergraduate courses in the 460 Government and Government aided General Degree Colleges/ Higher Education Institutions including Universities across the State of West Bengal for the academic session 2026-27, **as per the attached schedule.**

#### **Exclusions from the Centralized Online Admission System:**

Presidency University, Jadavpur University, Autonomous Colleges, Minority Educational Institutes/Colleges, Training Colleges, Law Colleges/Universities offering course like Fine Arts and Performing Arts, Crafts, Dance, Music, Colleges offering Engineering, Pharmacy, Nursing, Medical Courses and Self-financing/Private Colleges.

The Portal aims to provide opportunities to the students, to choose their desired course in the desired colleges via a single window platform and also to stop admission in multiple times by a single student at various colleges/ Universities so that maximum number of seats can be filled up in all Colleges/ Universities.

An Indian student can apply online through the following websites - <https://banglaruchchashiksha.wb.gov.in>, <https://wbsche.wb.gov.in> by clicking the "Centralised Admission" button or directly to <https://wbcap.in/>. **There is no Fee for Application.**

Any Indian student who has qualified (10+2) or equivalent examination from any recognized Board/ Council/ Equivalent body within the country, can apply for admission to the undergraduate courses.

An applicant can apply for a **maximum of 25 programmes/ courses** in one or multiple Higher Educational Institutions across the State. An applicant can create a Preference List, Institution-wise and Course-wise. User Manual and Tutorials have been provided in the Portal for step-by-step guidance to the students.

**Modalities:**

Online Admission Process should be done strictly on the basis of merit. Prospective students should not be called for counselling or verification of documents during the process of admission. No physical presence will be required at the Higher Education Institutions.

Eligible Applicants will be notified directly by the System through SMS and E-mail at each step. The applicants will also be able to see individual status through the applicants' own dashboard. Payment of fees for admission shall be done only through this Portal.

All Stakeholders shall adhere to the guidelines of COVID-19, issued by the Government from time to time. However, the Netaji Subhas Open University shall follow the time schedule as per guidelines of Open Distance Learning as done last year.

This advisory does not apply to admission to Teachers' Training courses such as B.Ed, B.P.Ed, M.Ed., or M.P.Ed including PG courses etc., for which separate Notification will be issued.

This is issued with the approval of competent authority and will remain in effect until further order.

The State Higher Education Department has launched a centralized online portal for undergraduate admissions for the 2026-27 academic year. The portal has been made visible from 14.05.2026, while, the portal will become LIVE from **18.05.2026. There is no Fee for Application.**

Registration & Application submission deadline: **18<sup>th</sup> May, 2026 to 1<sup>st</sup> June, 2026**

Autonomous Colleges, Minority Educational Institutes/Colleges, Training Colleges, Law Colleges/Universities offering courses like Fine Arts and Performing Arts, Crafts, Dance, Music, Colleges offering Engineering, Pharmacy, Nursing, Medical Courses and Self-Financing/Private Colleges\* for the present and such other Colleges/Universities/Courses as may be determined and notified by the State Government from time to time, shall be out of the purview of the Centralised Admission System.

The authorities of the educational institutions/courses mentioned above which will remain outside the state's Centralised Admission System must complete the process of receiving admission applications through their own methods within the time limit set by the state government (**18<sup>th</sup> May, 2026 to 1<sup>st</sup> June, 2026**) and complete the admission process within the schedule set by the state government.

**PART 'A'**

**Admission Rules for the First Semester in 4-Year Honours Level for the 2026-2027 Academic Year**

It is hereby informed to all that the admission process will be completed by following the instructions of the Higher Education Department of the Government of West Bengal and the admission rules mentioned herein under:

1. Students who have passed Higher Secondary (10+2) or equivalent examination from a recognized council/board/university in 2022/2023/2024/2025/2026 can participate in the college first semester admission process and will be admitted on the basis of the merit index scores and the tie-breaking rules wherever applicable.
2. For admission to the four-year (Hons.) level, a minimum of 45% marks obtained in aggregate in the best four subjects having full marks 100 each in the Higher Secondary (10+2) or equivalent examination is required. For Music\*\* and Santali subjects, a minimum of 40% marks obtained in aggregate in the best four subjects having full

marks 100 each is required, and students who have passed the Higher Secondary (10+2) or equivalent examination without the Santali subject can also apply for admission to the honours level in Santali subject. For laboratory-dependent subjects, one must pass separately in Theory and Practical. For subjects that are not laboratory - based, one must pass in Theory and Project separately.

3. All government orders (G.O.)/notifications (Extant Rules) regarding admission and reservation will be applicable in this case.

4. Students who were admitted to the first semester at the undergraduate level in the 2022-23/2023-24/2024-25/2025-26 academic session and after registration with the university stopped studying in the specified academic session and are considered eligible according to the rules for the 2026-27 academic year, can get admitted anew (not re-admission) in any course in the first year first semester at any college under this university if they get a place in the merit list within the intake capacity according to the university's admission rules. In this case, they will get a maximum of two chances of admission in the same college. They do not need to register anew. The previous registration will remain valid. They only need to fill the enrolment form. However, if a student has already been awarded a Bachelor's Degree from the university, such a student cannot be admitted again in Regular Mode to any college under this University.

5. a. To be admitted in Economics (Major), one must have pass marks in Mathematics / Business Mathematics / Applied Mathematics subject(s) from any recognized council or board or university in the Higher Secondary (10+2) or equivalent examination.

b. To be admitted in Nutrition (Major), one must have pass marks in Chemistry subject from any recognized council or board or university in the Higher Secondary (10+2) or equivalent examination.

c. To be admitted in the BSc in Bio-Chemistry (Major) course, one must have pass marks in Chemistry and Biological Science or Life Science subjects in the science stream from any recognized council or board or university in the Higher Secondary (10+2) or equivalent examination.

d. To be admitted in the BSc in Biotechnology (Major) course, one must have pass marks in Physics, Chemistry and Biological Science subjects in the science stream from any recognized council or board or university in the Higher Secondary (10+2) or equivalent examination.

e. To be admitted in BBA (Hons) in Business Administration (Major) and BBA (Hons) in Tourism and Hospitality (Major), one must pass the Higher Secondary (10+2) or equivalent examination from any recognized council/board/university.

f. To be admitted in BCA (Hons) in Computer Application (Major), one must pass the Higher Secondary (10+2) or equivalent examination from any recognized council/board/university in Mathematics / Statistics / Computer Science / Computer Application / ITEV / Business Economics & Maths (BEM) / IT & ITES / Artificial Intelligence / Modern Computer Application / Data Science / Typography and Computer Application / Applied Mathematics / Web Application subjects. Students who have passed the (10+2) or equivalent examination with Information Practice subject from CBSE Board can also be admitted in BCA (Hons) in Computer Application (Major) subject.

g. Students who have completed Vocational Engineering & Technology (with pass marks in Mathematics) in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester of the first year at the level of BCA (Hons) in Computer Application (Major)/BBA (Hons) in Business Administration (Major)/BSc (Hons.) in Computer Science (Major).

h. Students who have passed Vocational Agriculture in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester at the level of BBA (Hons) in Business Administration (Major).

i. Students who have passed Vocational Business and Commerce in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester at the level of BCom (Hons) in Accounting and Management (Major)/BBA (Hons) in Business Administration (Major).

j. Students who have passed Vocational Home Science in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester of BBA (Hons) in Business Administration (Major).

6. To be admitted in the four-year Bachelor of Fine Arts (BFA) in Painting, Sculpture & Applied Art specialization, one must pass the Higher Secondary (10+2) or equivalent examination from any recognized council or board or university.

7. For four-year honours level students, the Major subject will be considered as the Hons. subject and a student cannot change the subject finalized as the Major Subject in Semester-I in the future.

It is hereby informed to all that the admission process will be completed by following the instructions of the Higher Education Department of the Government of West Bengal and the admission rules mentioned herein under:

1. Students who have passed Higher Secondary (10+2) or equivalent examination from a recognized council/board/university in 2022/2023/2024/2025/2026 can participate in the college first semester admission process and will be admitted on the basis of the merit index scores and the tie-breaking rules wherever applicable.
2. For admission to the four-year (Hons.) level, a minimum of 45% marks obtained in aggregate in the best four subjects having full marks 100 each in the Higher Secondary (10+2) or equivalent examination is required. For Music\*\* and Santali subjects, a minimum of 40% marks obtained in aggregate in the best four subjects having full

Students who have passed the (10+2) or equivalent examination with Information Practice subject from CBSE Board can also be admitted in BCA (Hons) in Computer Application (Major) subject.

g. Students who have completed Vocational Engineering & Technology (with pass marks in Mathematics) in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester of the first year at the level of BCA (Hons) in Computer Application (Major)/BBA (Hons) in Business Administration (Major)/BSc (Hons.) in Computer Science (Major).

h. Students who have passed Vocational Agriculture in the Higher Secondary (10+2) or equivalent examination can be admitted to the first semester at the level of BBA (Hons) in Business Administration (Major).

- a UG Certificate after completing 1 year (2 Semesters) of study in the chosen fields of study, provided that a skill based vocational course (additional 4 credits) must be completed during the summer term by the students who will exit the programme after securing 40 credits. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of six (6) years.
  - a UG Diploma after 2 years (4 Semesters) of study, provided that a skill based vocational course (additional 4 credits) must be completed during the summer term by the students who will exit the programme after securing 87 credits. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of six (6) years.
  - a Bachelor's Degree after completion of 3-years (6 Semesters) programme of study securing 128 credits.
17. If a student wants to pursue the four-year honours level after getting admitted to the three-year undergraduate level at the time of admission, the student will get the opportunity for Lateral entry if their Major Subject CGPA up to the 6th Semester is equivalent to at least 70% marks. In this case, students will get the opportunity for admission to the 7th Semester in that college based on their obtained marks, by increasing the total seats in that Major subject for 4 Yrs. Honours Programme by a maximum of 10% for that year only. In the case of these increased seats, the government reservation policy will be applicable. The entire process must be completed within ten days after the publication of the 6th Semester result. The concerned college authorities will take necessary action to get the list of those students approved by the university authorities.
